## **BOAT AND WATERCRAFT REGISTRATION**

All Boats and Watercraft which have previously been assigned to, and are currently being stored at, an SRCA Designated Storage Space, must be registered with Collect Associates by April 1 of each year, regardless of when an initial storage application was submitted and approved for such Boat or Watercraft. Unit Owners must also pay a registration fee of \$25.00 for each Boat or Watercraft being registered. This Boat and Watercraft Registration Form must be completed and submitted to Collect Associates, together with the applicable registration fee, by April 1 each year in order to continue use of the assigned SRCA Designated Storage Space. See Rule #22 of SRCA's Rules and Regulations and Policies (as amended and replaced effective March 1, 2018) which applies to all boats and watercraft, including Boats and Watercraft, stored on SRCA Property.

Please complete and return this registration form with a check in the amount of \*\$25.00 made out to Savin Rock Condominiums Association, Inc. with (or before) your next common fee payment to **Collect Associates, 392 River Road, Shelton, CT 06484**. \*If you are registering 2 Watercraft, the registration fee is \$50.00.

Failure to accurately complete and return this registration form by April 1 each year may result in imposition of fines and other remedial action in accordance with SRCA's Rules and Regulations.

Unit Owners must immediately report to Collect Associates any changes in their Unit's Residents' boats or watercraft residing on SRCA Property. <u>Any changes will require submission of a new application for storage.</u>

Note, SRCA may assign a different SRCA Designated Storage Space to any Boat or Watercraft that has previously received approval for storage on SRCA Property.
