BOAT AND WATERCRAFT STORAGE APPLICATION

A Unit Owner wishing to store a Boat or Watercraft on SRCA property **must complete and submit this application form to Collect Associates along with a \$25.00 application fee for each Boat or Watercraft for which a storage space is desired.**

Upon approval of a storage application by Collect Associates, a designated storage space on SRCA Property will be assigned to the approved Boat or Watercraft, if available. The Unit Owner will receive a tag which must be affixed to the approved Boat or Watercraft per instructions given by Collect Associates.

Given the limited number of storage spaces available, applications will be reviewed for approval on a first come, first served basis. **Applicants are therefore not guaranteed a storage space.**

Only Boats and Watercraft that are in compliance with Rule #22 (as amended and replaced effective March 1, 2018) of SRCA's Rules and Regulations are eligible for storage at an SRCA Designated Storage Space (as defined in Rule #22). Rule #22 applies to storage of all boats and watercraft on SRCA Property.

All Boats and Watercraft which have previously been assigned to, and are currently being stored at, an SRCA Designated Storage Space, must be registered with Collect Associates by April 1 of each year, regardless of when a storage application was submitted and approved for such Boat or Watercraft. Unit Owners must also pay a registration fee of \$25.00 for each Boat or Watercraft being registered. A separate, Registration Form must be completed and submitted to **Collect Associates, 392 River Road, Shelton, CT 06484**, together with the applicable registration fee, by April 1 each year in order to continue use of an assigned SRCA Designated Storage Space. See Rule #22 of SRCA's Rules and Regulations (as amended and replaced effective March 1, 2018).

Please complete and return this application form with a check in the amount of *\$25.00 made out to Savin Rock Condominiums Association, Inc. to Collect Associates, 392 River Road, Shelton, CT 06484. ***Only one Boat or two Watercraft** is permitted to be stored on SRCA property **per unit**. If you are registering 2 Watercraft, the application fee is \$50.00.

Failure to accurately complete and return this application form and receive approval for storage of a Boat or Watercraft at an SRCA Designated Storage Space may result in imposition of fines and other remedial action in accordance with SRCA's Rules and Regulations.

Unit Owners must immediately report to Collect Associates any changes in their Unit's Residents' boats or watercraft residing on SRCA Property. Any changes will require submission of a new application for storage.
